

Re: Overlapping spacing units

Ladies and gentlemen:

As you are aware, Mewbourne Oil Company (“Mewbourne”) has proposed the drilling of the Wild Turkey 36/35 B3AD State Com. Well No. 1H on the above-described lands to a depth sufficient to test the Third Bone Spring Sand. The N/2NE/4 §35 and the N/2N/2 §36-18S-28E, NMPM are in the well unit for the Wild Turkey 36/35 B2AD State Com. Well No. 1H (operated by Mewbourne), which has been drilled and completed in the Second Bone Spring Sand. All interest owners in the B2AB well are in the well unit for the B3AD well. However, the interest owners in the N/2NW/4 §35 own no interest in the B2AB well.

Mewbourne provides this notice pursuant to NMAC 19.15.16.15.B(9)(b). Because of the different sands being tested by the two wells, and the geological barrier between the two zones, Mewbourne expects no effects on the B2AB well from the drilling and completion of the B3AD well. In addition, distribution of production proceeds to the interest owners in the B2AB well will not change upon the drilling of the B3AD well. However the Oil Conservation Division’s Rule cited above requires Mewbourne to notify you of the overlapping well units. If you have any objection to Mewbourne filing an Application for Permit to Drill the B3AD well, you must deliver to a written statement of such objection to Mewbourne within 20 days of the date of this letter.
