The Unit will be dedicated to the **Sapphire Fed Com 501H Well** (API No. Pending), to be horizontally drilled from a surface location in the  $NW\frac{1}{4}NW\frac{1}{4}$  (Lot D) of Section 14, to a bottom hole location in the  $SW\frac{1}{4}SW\frac{1}{4}$  (Lot M) of Section 23. The completed interval of the Well will be orthodox.
