APPLICANT’S STATEMENT OF THE CASE

In these consolidated cases, Matador seeks to add additional pooled parties to the terms of pooling orders R-21811 and R-21812 issued by the Division following the consolidation and hearing of Case Nos. 22052 and 22053 in August of 2021. This series of orders pooled uncommitted interest owners in two laydown spacing units in the Bone Spring formation (Malaga; Bone Spring Pool [Pool code 42780]) underlying Sections 14 and 15, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico, as follows:

- Order R-21811 pooled the N/2 N/2 of Sections 14 and 15 currently dedicated to the **Bubba Burton Com #111H well** (API No. 30-015-48081) and the **Bubba Burton Com #121H well** (API No. 30-015-48082), both horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 14 to a bottomhole location in the NW/4 NW/4 (Unit D) of Section 15.
- Order R-21812 pooled the S/2 N/2 of Sections 14 and 15 currently dedicated to the **Ken Wilson Com #112H well** (API No. 30-015-48103) and the **Ken Wilson Com #122H well** (API No. 30-015-48106), both horizontally drilled from a surface location in the SE/4 NE/4 (Unit H) of Section 14 to a bottomhole location in the SW/4 NW/4 (Unit E) of Section 15.
