**MOTION TO VACATE PRE-HEARING ORDER**

EOG Resources, Inc. ("EOG") moves the Division to vacate the Pre-Hearing Order entered in these matters and instead hold a status conference at the August 4<sup>th</sup>, 2022, docket. In support thereof, EOG states:

1. These matters seek to create standard horizontal well spacing units in the Bone Spring and Wolfcamp formations underlying the W/2 of Sections 22 and 27, Township 19 South, Range 33 East, NMPM, to be dedicated to the Moonraker wells proposed by E.G.L. Resources, Inc. ("EGL Resources").

2. EOG owns the W/2 of Section 27 and is informed EGL Resources has a limited interest in the W/2 of Section 22, thereby holding only a 25% working interest in the proposed spacing units.

3. Following the May 19, 2022, docket call on these matters, the Division issued a Pre-Hearing Order setting these matters for a contested hearing on August 4, 2022.

4. Efforts by EOG and EGL Resources since the May hearing to reach a voluntary agreement for the development of this acreage have failed, resulting in EOG recently proposing the Goldfinger wells for the subject acreage.

5. EOG's competing pooling applications for the proposed Goldfinger wells will appear on the September 1, 2022, Division docket.

6. To avoid separate hearings on competing proposals, the Pre-Hearing Order issued in these matters should be vacated and a scheduling conference held on August 4<sup>th</sup> for the purpose of setting a new hearing date to address the competing pooling applications.

7. Neither party is prejudiced by a holding a contested hearing at a later date.

8. EGL Resources has been contacted about this motion and does not oppose vacating the prehearing order but desires a contested hearing on September 1, 2022, docket.

WHEREFORE, EOG requests that the Prehearing Order issued in these matters be vacated in favor of a status conference on the August 4, 2022, docket.
