**STATEMENT OF THE CASE**

Applicant applies for an order pooling all uncommitted interests in the San Andres formation underlying a 160-acre, more or less, standard horizontal spacing unit (“Unit”) comprised of Lot 1, SE/4 NE/4 and E/2 SE/4 (E/2 E/2 equivalent) of Section 1, Township 9 South, Range 33 East, Lea County, New Mexico. The Unit will be dedicated to the Palisade #1H well, which will be horizontally drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 12, Township 9 South, Range 33 East, to a bottom hole location in Lot 1 of Section 1, Township 9 South, Range 33 East. The completed interval of the Well will be orthodox.

Also to be considered in each case will be the cost of drilling and completing the Well and the allocation of the costs, the designation of Applicant as the operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well.
