


- a. Case 22835: the W/2SE/4 of Section 17, the W/2E/2 of Section 20, and the W/2NE/4 of Section 29, Township 21 South, Range 35 East, NMPM, Lea County, New Mexico. The unit will be dedicated to the North Wilson Deep Unit Well No. 6H; and
- b. Case 22836: the E/2SE/4 of Section 17, the E/2E/2 of Section 20, and the E/2NE/4 of Section 29, Township 21 South, Range 35 East, NMPM, Lea County, New Mexico. The unit will be dedicated to the North Wilson Deep Unit Well No. 7H.

These matters are scheduled for hearing at 8:15 a.m. on Thursday, June 2, 2022. During the COVID-19 Public Health Emergency, state buildings are closed to the public and the hearing will be conducted remotely. and his or her attorney; a concise statement of the case; the name(s) of the witness(es) the party will call to testify at the hearing; the approximate time the party will need to present his or her case; and identification of any procedural matters that need to be resolved prior to the hearing. The Pre-Hearing Statement must also be provided to the undersigned.
