**UNOPPOSED MOTION TO DISMISS THE CHISHOLM ENERGY CASES AND TO  
SUBSTITUTE THE EARTHSTONE OPERATING CASES IN THE AMENDED  
PREHEARING ORDER**

Chisholm Energy Operating, LLC and Earthstone Operating, LLC move to dismiss Case Nos. 21849, 21850, 22393 and 22394 (“Chisholm Cases”) and to add Cases 22978, 22979, 22980 and 22981 (“Earthstone Cases”) to the Amended Prehearing Order governing these matters. The Earthstone Cases replace the Chisholm Cases, involved the same acreage, and are currently set to appear on the Division’s September 1st docket.

At the Status Conference held on August 18th for the Chisholm Cases and the competing Mewbourne Cases 22161-22164, the Examiner and the parties agreed to the issuance of an Amended Prehearing Order that will set the remaining Earthstone Cases and the Mewbourne Cases for a status conference on the Division’s November 3rd docket.
