# APPLICANT'S STATEMENT OF THE CASE

Matador seeks orders approving and then pooling overlapping horizontal well spacing units

in the Bone Spring and Wolfcamp formations underlying the S/2 of irregular Sections 1 and 2,

Township 21 South, Range 28 East, and the SW/4 equivalent of irregular Section 6, Township 21

South, Range 29 East, NMPM, Eddy County, New Mexico, as follows:

- Case 22912 seeks approval and pooling of an overlapping 390.36-acre horizontal well spacing unit in the <u>Bone Spring</u> formation comprised of the N/2 SW/4 and N/2 SE/4 of Sections 1 and 2, and Lot 17 and NE/4 SW/4 of Section 6, to be initially dedicated to the to the proposed Simon Camamile 0206 Fed Com 115H and 125H wells to be drilled from a surface location within the SW/4 SW/4 of Section 2 to a bottom hole location within NE/4 SW/4 of Section 6. This 390.36-acre horizontal well spacing unit will overlap a proposed 780.68-acre horizontal well spacing unit in the Bone Spring formation comprised of S/2 of Sections 1 and 2, and Lots 17-18, NE/4 SW/4 and SE/4 SW/4 of Section 6, to be dedicated to the proposed Simon Camamile 0206 Fed Com 136H well.

This 780.68-acre horizontal well spacing unit will overlap (a) a 390.36-acre horizontal well spacing unit comprised of the N/2 SW/4 and N/2 SE/4 of Sections 1 and 2, and Lot 17 and the NE/4 SW/4 of Section 6, to be dedicated to the proposed Simon Camamile 0206

Fed Com 115H and 125H wells, and (b) a 390.32-acre horizontal well spacing unit comprised of the S/2 SW/4 and S/2 SE/4 of Sections 1 and 2, and Lot 18 and SE/4 SW/4 of Section 6, to be dedicated to the proposed Simon Camamile 0206 Fed Com 116H and 126H wells.

- Case 22917 seeks approval and pooling of an overlapping 780.68-acre horizontal well spacing unit in the <u>Wolfcamp</u> formation comprised of the S/2 of Sections 1 and 2, and Lots 17-18, NE/4 SW/4 and SE/4 SW/4 of Section 6, to be initially dedicated to the proposed Simon Camamile 0206 Fed Com 226H well to be drilled from a surface location within the SW/4 SW/4 of Section 2 to a bottom hole location within NE/4 SW/4 of Section 6. This 780.68-acre horizontal well spacing unit will overlap (a) a 390.36-acre horizontal well spacing unit comprised of the N/2 SW/4 and N/2 SE/4 of Sections 1 and 2, and Lot 17 and the NE/4 SW/4 of Section 6, to be dedicated to the proposed Simon Camamile 0206 Fed Com 205H well, and (b) a 390.32-acre horizontal well spacing unit comprised of the S/2 SW/4 and S/2 SE/4 of Sections 1 and 2, and Lot 18 and SE/4 SW/4 of Section 6, to be dedicated to the proposed Simon Camamile 0206 Fed Com 205H well, and (b) a 390.32-acre horizontal well spacing unit comprised of the S/2 SW/4 and S/2 SE/4 of Sections 1 and 2, and Lot 18 and SE/4 SW/4 of Section 6, to be dedicated to the proposed Simon Camamile 0206 Fed Com 205H well.
