STATEMENT OF CASES

In Case No. 22995 Novo seeks an order from the Oil Conservation Division pooling all uncommitted mineral interests within a Wolfcamp horizontal spacing unit underlying the W/2

of Section 26 Township 22 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. The spacing unit will be dedicated to the Crocubot Fed 26 211H, Crocubot Fed 26 212H, Crocubot Fed 26 231H, and Crocubot Fed 26 232H wells, to be horizontally drilled. The wells will be drilled at orthodox locations. The completed interval for the Crocubot Fed 26 211H and the Crocubot Fed 26 212H wells will be less than 330' from the adjoining tracts to allow inclusion of proximity tracts within the proposed standard horizontal spacing unit.

In Case No. 22996 Novo seeks an order from the Oil Conservation Division pooling all uncommitted mineral interests within a Bone Spring horizontal spacing unit underlying the W/2W/2 of Section 26, Township 22 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. The spacing unit will be dedicated to the Crocubot Fed 26 135H and Crocubot Fed 26 131H wells, to be horizontally drilled. The wells will be drilled at orthodox locations.

In Case No. 22997 Novo seeks an order from the Oil Conservation Division pooling all uncommitted mineral interests within a Bone Spring horizontal spacing unit underlying the E/2W/2 of Section 26, Township 22 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. The spacing unit will be dedicated to the Crocubot Fed 26 215H and Crocubot Fed 26 132H wells, to be horizontally drilled. The wells will be drilled at orthodox locations.
