STATEMENT OF THE CASE

APPLICANT

Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation, limited to depths from the top of the First Bone Spring to the base of the Second Bone Spring, underlying a horizontal spacing unit comprised of the W/2E/2 of Section 15 and the W/2E/2 of Section 10, Township 23 South, Range 34 East, NMPM. The unit will be dedicated to the Ibex 15/10 B1OB Fed. Com. Well No. 1H and the Ibex 15/10 B2OB Fed. Com. Well No. 1H, horizontal wells with first take points in the SW/4SE/4 of Section 15 and last take points in the NW/4NE/4 of Section 10. Also to be considered will be the cost of drilling, completing, and equipping the wells and the allocation of the cost thereof, as well as actual

operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, and equipping the wells.


