**STATEMENT OF THE CASE**

In **Case No. 23047**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 639.65-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Section 19, Township 20 South, Range 27 East and the N/2 of Section 24, Township 20 South, Range 26 East, Eddy County, New Mexico. The Unit will be dedicated to the following wells:

- **Le Mans 2419 State Com #301H**, which will be horizontally drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 24, Township 20 South, Range

26 East, to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 19, Township 20 South, Range 27 East;

- **Le Mans 2419 State Com #302H**, which will be horizontally drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 24, Township 20 South, Range 26 East, to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 19, Township 20 South, Range 27 East; and
- **Le Mans 2419 State Com #303H**, which will be horizontally drilled from a surface hole location in the SW/4 NW/4 (Unit E) of Section 24, Township 20 South, Range 26 East, to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 19, Township 20 South, Range 27 East.

The completed intervals of the Wells will be orthodox. The completed interval of the Le Mans 2419 State Com #302H well will be located within 330' of the quarter-quarter section line separating the N/2 N/2 and S/2 N/2 of Section 19, Township 20 South, Range 27 East and Section 24, Township 20 South, Range 26 East, to allow for the creation of a 639.65-acre standard horizontal spacing unit.

In **Case No. 23048**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 640.15-acre, more or less, standard horizontal spacing unit comprised of the S/2 of Section 19, Township 20 South, Range 27 East and the S/2 of Section 24, Township 20 South, Range 26 East, Eddy County, New Mexico. The Unit will be dedicated to the following wells:

- **Le Mans 2419 State Com #304H**, which will be horizontally drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 24, Township 20 South, Range

26 East, to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 19, Township 20 South, Range 27 East;

- **Le Mans 2419 State Com #305H**, which will be horizontally drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 24, Township 20 South, Range 26 East, to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 19, Township 20 South, Range 27 East; and
- **Le Mans 2419 State Com #306H**, which will be horizontally drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 24, Township 20 South, Range 26 East, to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 19, Township 20 South, Range 27 East.

The completed intervals of the Wells will be orthodox. The completed interval of the Le Mans 2419 State Com #305H well will be located within 330’ of the quarter-quarter section line separating the S/2 S/2 and N/2 S/2 of Section 19, Township 20 South, Range 27 East and Section 24, Township 20 South, Range 26 East, to allow for the creation of a 640.15-acre standard horizontal spacing unit.

Also to be considered in each case will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of Applicant as the operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells. The Wells are located approximately 10 miles Northwest of Carlsbad, New Mexico.
