STATEMENT OF THE CASE

APPLICANT

Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Wolfcamp formation underlying a horizontal spacing unit comprised of the N/2 of Section 33, Township 22 South, Range 27 East, NMPM. The unit will be dedicated to the Hot Shots 33 W0AD Fee Well No. 1H, with a first take point in the NE/4NE/4 of 33 and a last take point in the NW/4NW/4 of Section 33, and the Hot Shots 33 W0HE Fee Well No. 1H, with a first take point in the SE/4NE/4 of 33 and a last take point in the SW/4NW/4 of Section 33. Also to be considered will be the cost of drilling, completing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, and equipping the wells.


