STATEMENT OF THE CASE

Applicant applies for an order pooling all uncommitted interests from the top of the Third Bone Spring Formation to the base of the Bone Spring Formation underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Section 13, Township 20 South, Range 28 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Wombat 13 Federal Com 133H** well, to be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 13 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 13.

Due to a depth severance, Applicant seeks to pool interests from the stratigraphic equivalent of approximately 7,900' TVD to approximately 8,966' TVD, as shown on the Charlie Chocolate 14 15 Federal Com #031H well log (API #30-015-43123).

The completed interval of the Well will be orthodox. Also to be considered will be the cost of drilling and completing the Well and the allocation of the costs, the designation of Applicant as the operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well.

The Well is located approximately 10.2 miles northeast of Carlsbad, New Mexico.
