**STATEMENT OF THE CASE**

Applicant applies for an order pooling all uncommitted interests within the Yeso formation underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Section 23, Township 17 South, Range 28 East, Eddy County, New Mexico. The spacing unit will be dedicated to the following wells:

- **Sierra Nevada 23 State Com 10H well**, which will be horizontally drilled from a surface hole location in the NE/4 NW/4 (Unit C) of Section 23, Township 17 South, Range 28 East, to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 23, Township 17 South, Range 28 East; and
- **Sierra Nevada 23 State Com 60H well**, which will be horizontally drilled from a surface hole location in the NE/4 NW/4 (Unit C) of Section 23, Township 17 South, Range 28 East, to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 23, Township 17 South, Range 28 East.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of Applicant as the operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells.

The wells are located approximately 14.3 miles East and 1.03 miles South of Artesia, New Mexico.
