STATEMENT OF THE CASE

In **Case No. 23111**, Applicant applies for an order pooling all uncommitted interests within the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Sections 16 and 17, Township 20 South, Range 28 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Dingo 17 Federal Com 201H well**, to be

drilled from a surface hole location in the SE/4 NE/4 (Unit H) of Section 18 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 16.

In **Case No. 23112**, Applicant applies for an order pooling all uncommitted interests within the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Sections 16 and 17, Township 20 South, Range 28 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Dingo 17 Federal Com 203H well**, to be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 18 to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 16.

In **Case No. 23113**, Applicant applies for an order pooling all uncommitted interests within the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 16 and 17, Township 20 South, Range 28 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Dingo 17 Federal Com 202H well**, to be drilled from a surface hole location in the SE/4 NE/4 (Unit H) of Section 18 to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 16.

In **Case No. 23114**, Applicant applies for an order pooling all uncommitted interests within the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Sections 16 and 17, Township 20 South, Range 28 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Dingo 17 Federal Com 204H well**, to be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 18 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 16.

The completed intervals of the Wells will be orthodox. Also to be considered in each case will be the cost of drilling and completing the Wells and the allocation of the costs, the designation

of Applicant as the operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells.

The Wells are located approximately 9.1 miles north of Carlsbad, New Mexico.
