STATEMENT OF THE CASE

APPLICANT

Mewbourne Oil Company seeks an order pooling all mineral interests in the Wolfcamp formation underlying a horizontal spacing unit comprised of the S/2 of Section 31, Township 23 South, Range 27 East, N.M.P.M. and the S/2 of Section 36, Township 23 South, Range 26 East, N.M.P.M., Eddy County, New Mexico, The unit will be dedicated to (a) the Charlie 31/36 W2IL State. Com. Well No. 1H, with a first take point in the NE/4SE/4 of Section 31 and a last take point in the NW/4SW/4 of Section 36, and (b) the Charlie 31/36 W2PM State Com. Well No. 1H, with a first take point in the SE/4SE/4 of Section 31 and a last take point in the SW/4SW/4 of Section 36. Also to be considered will be the cost of drilling, completing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, and equipping the wells.
