The completed intervals of the Wells will be orthodox.

The Unit will be dedicated to the Mad Max 6 Fed Com 131H well, which will be horizontally drilled from a surface hole location in the SE/4 NE/4 (Unit H) of Section 1, Township 20 South, Range 27 East, to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 5, Township 20 South, Range 28 East.
