



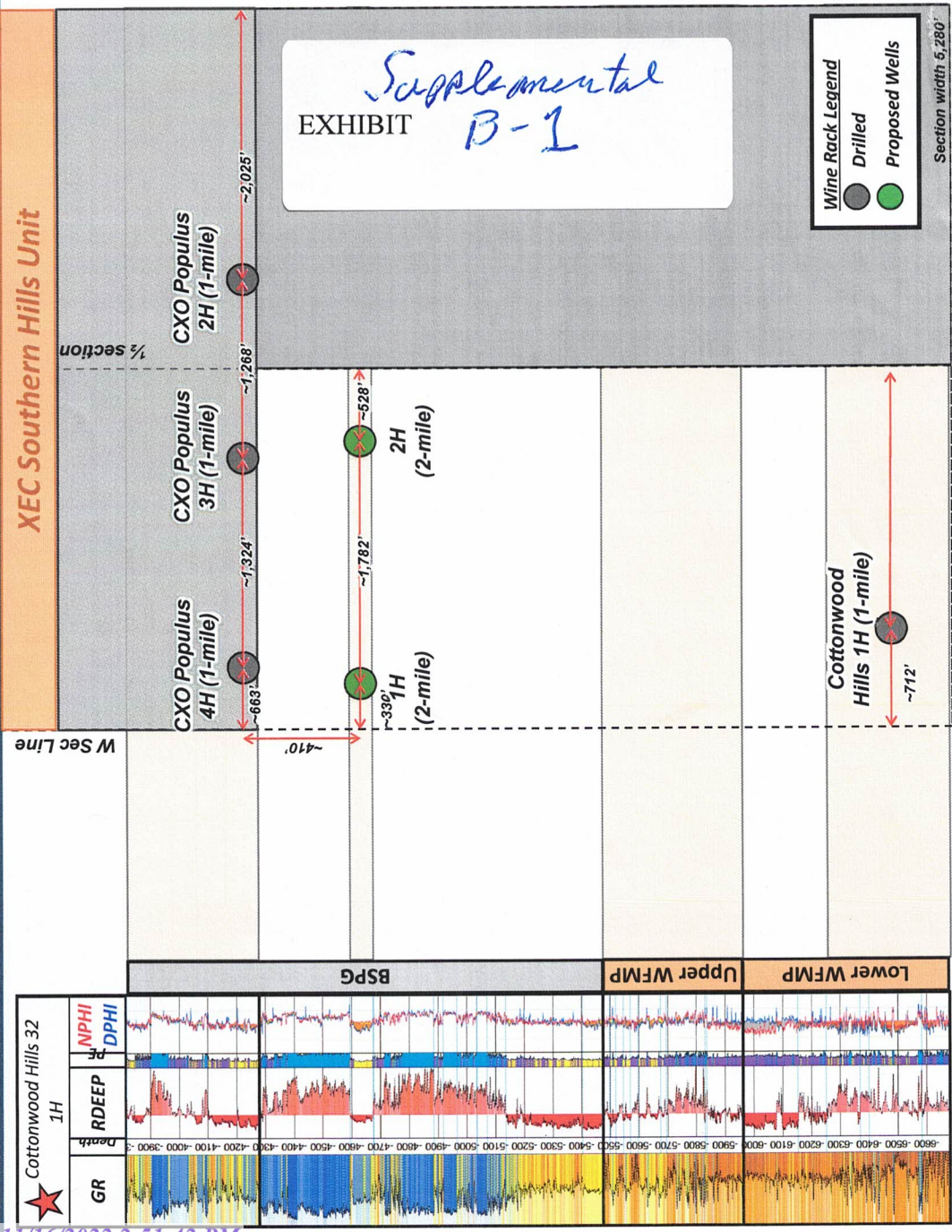

Southern Hills Wine Rack (Sec 29)






E Sec Line
