STATEMENT OF THE CASE

In **Case No. 23188**, COG applies for an order pooling all uncommitted interests in the Bone Spring formation, Red Hills; Upper Bone Spring Shale Pool (Pool Code 97900), underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Section 25, Township 25 South, Range 33 East, Lea County, New Mexico. The spacing unit will be dedicated to the following wells:

- **Dominator 25 Federal Com 106H** well, to be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 25 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 25; and

- **Dominator 25 Federal Com 306H** well, to be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 25 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 25.

In **Case No. 23189**, COG applies for an order pooling all uncommitted interests in the Bone Spring formation, Red Hills; Lower Bone Spring Pool (Pool Code 51020), underlying a 160-acre, more or less standard horizontal spacing unit comprised of the E/2 W/2 of Section 25, Township 25 South, Range 33 East, Lea County, New Mexico. The spacing unit will be dedicated to the **Dominator 25 Federal Com 406H** well, to be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 25 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 25.

In **Case No. 23190**, COG applies for an order pooling all uncommitted interests in the Bone Spring formation, Red Hills; Upper Bone Spring Shale Pool (Pool Code 97900), underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Section 25, Township 25 South, Range 33 East, Lea County, New Mexico. The spacing unit will be dedicated to the following wells:

- **Dominator 25 Federal Com 104H** well, to be drilled from a surface hole location in the SW/4 SE/4 (Unit O) of Section 25 to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 25; and
- **Dominator 25 Federal Com 304H** well, to be drilled from a surface hole location in the SW/4 SE/4 (Unit O) of Section 25 to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 25.

In **Case No. 23191**, COG applies for an order pooling all uncommitted interests in the Bone Spring formation, Red Hills; Lower Bone Spring Pool (Pool Code 51020), underlying a 160-acre, more or less standard horizontal spacing unit comprised of the W/2 E/2 of Section 25, Township 25 South, Range 33 East, Lea County, New Mexico. The spacing unit will be dedicated to the

Dominator 25 Federal Com 404H well, to be drilled from a surface hole location in the SW/4 SE/4 (Unit O) of Section 25 to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 25.

The completed intervals of the Dominator 25 Federal Com wells will be orthodox. Also to be considered in each case will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The Dominator 25 Federal Com wells are located approximately 19 miles west of Jal, New Mexico.
