APPLICANT'S STATEMENT OF THE CASE

In this case, Redwood seeks an order pooling all uncommitted interests in the Yeso formation (Red Lake; Glorieta-Yeso [Pool code 51120]) underlying a standard 160-acre, more or less, horizontal spacing unit comprised of the N/2 N/2 of Section 17, Township 18 South, Range 27 East, NMPM, Eddy County, New Mexico. Redwood proposes to dedicate the above-referenced

spacing unit to the proposed initial **Sparkplug 17 Federal Com #1H, Sparkplug 17 Federal Com #2H, and Sparkplug 17 Federal Com #3H** wells, all to be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 9, to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 17. The completed interval for each of the wells will comply with statewide setbacks for oil wells. Redwood has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
