

SELF-AFFIRMED STATEMENT OF BRENDON KUSHNERICK

Brendon Kushnerick deposes and states:

1. I am over the age of 18, and have personal knowledge of the matters stated herein.
2. I am a landman for Kaiser-Francis Oil Company ("KFOC"). I have been qualified by the Division as an expert petroleum landman.
3. In these cases KFOC seeks to pool the Bone Spring and Wolfcamp formations underlying horizontal spacing units comprised of the SE/4 of Section 5 and the E/2 of Section 8, Township 24 South, Range 34 East, N.M.P.M., for the Bell Lake Unit South Well Nos. 217H & 218H (Bone Spring) and 417H and 418H (Wolfcamp).
4. At the hearing, I understand that questions were asked about the completion and producing status of the wells, and the status of regulatory filings related to those issues.
5. The wells are all completed and producing.
6. I met with KFOC's Regulatory Manager, and we discussed the status of the filings for the wells. Attached as Exhibit A is a spreadsheet prepared to show the filings which have been made. KFOC believes all pertinent filings have been made, or will be made when the regulatory bodies allow it.
7. The problem is that the Bureau of Land Management ("BLM") has not approved the well completion reports, filed nine months ago. As a result the Division has not approved them either, and will not allow production reports to be filed. KFOC does not know the reason for the BLM's delay; it has drilled approximately 118 wells in the Bell Lake Unit (North Block and South Block) and has complied with regulatory filing requirements on those wells.

I understand that this Self-Affirmed Statement will be used as written testimony in this case. I affirm that my testimony in paragraphs 1 through 5 above is true and correct and is made under penalty of perjury under the laws of the State of New Mexico.
