STATEMENT OF THE CASE

Earthstone applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 319.86-acre, more or less, standard horizontal spacing unit comprised of the E/2 E/2 of Section 34, Township 19 South, Range 33 East, and Lot 1, SE/4 NE/4, and E/2 SE/4 (E/2 E/2 equivalent) of irregular Section 3, Township 20 South, Range 33 East, Lea County, New Mexico. The spacing unit will be dedicated to the **Jade 34-3 Fed WCB Com 25H** well (“Well”), to be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 34, Township 19

South, Range 33 East to a proposed bottom hole location in the SE/4 SE/4 (Unit P) of Section 3, Township 20 South, Range 33 East.

The completed interval of the well will be orthodox. Also to be considered will be the cost of drilling and completing the well and the allocation of the costs, the designation of Applicant as the operator of the well, and a 200% charge for the risk involved in drilling and completing the well.

The well is located approximately 30 miles southwest of Hobbs, New Mexico.
