COLGATE OPERATING, LLC'S RESPONSE TO DOYLE AND MARGARET HARTMAN'S MOTION TO DISMISS

Colgate Operating, LLC ("Colgate") submits the following Response to Doyle and Margaret Hartman's ("Hartman") Motion to Dismiss.

- 1. In these cases, Colgate seeks to pool additional interests under the existing pooling orders on its Barman Fed Com Wells, which were issued on September 26, 2022. Hartman is named as a minority record title owner of the federal lease involved in these cases.
- 2. Hartman initially opposed Colgate's applications based on the unsupported claims that: (1) his record title interest cannot be pooled because he also owns a working interest that is not being pooled; and (2) there is no evidence the Bureau of Land Management ("BLM") accepts a pooling order in lieu of a communitization agreement signed by a record title owner. With respect to the first issue, the Division has previously ruled that the January 19, 2023 hearing will only address Colgate's request to pool Hartman's record title interest. Regarding the second issue, Colgate's hearing exhibits include its written communication with the BLM confirming that the BLM accepts a state pooling order in lieu of a communitization agreement signed by a record title owner.
- 3. Recognizing the futility of his arguments, Hartman now contends that Colgate has no right to drill on the federal leases, and should not be able to pool Hartman's record title interest, because the BLM has not yet approved interest conveyances to Colgate. *See generally* Hartman

Motion to Dismiss, filed January 17, 2022. As an initial matter, Hartman's supplemental exhibits on this issue are untimely and should be stricken. Regardless, this argument is factually and legally incorrect and merely constitutes another attempt by Hartman to thwart Colgate's development, resulting in waste and violating Colgate's correlative rights.

- 4. First, Hartman's claim that Colgate has no right to drill on the federal leases is factually incorrect. The BLM has approved Colgate's Applications for Permits to Drill ("APDs") for three of the Batman Fed Com wells, and Colgate expects the BLM to issue the remaining APDs shortly. *See* Supplemental Self-Affirmed Statement of T. Macha, attached as Exhibit D, and APDs, attached as Exhibit D-1.
- 5. Second, the conveyance of interest from Oxy USA, Inc. to Colgate has been fully executed and recorded in Lea County, New Mexico, and has also been submitted to the BLM. *See* Exh. D-2. Under New Mexico law, the filed conveyance is a valid transfer of an interest in real property. *See, e.g., Angle v. Slayton*, 1985-NMSC-032, ¶ 6, 697 P.2d 940. Further, Colgate is not aware of any reason the BLM would not approve the conveyance, especially since the BLM has already approved APDs. The BLM's administrative processes, including approval of conveyances, are often significantly delayed for various reasons.
- 6. Third, neither NMSA 1978, Section 70-2-17(C) nor any other provision requires an operator to obtain BLM approval of an interest conveyance prior to pooling. Because BLM administrative processes are often delayed, any such requirement would impermissibly limit the Division's pooling authority and impede oil and gas development in violation of the Oil and Gas Act. Rather, the statute and the Division's regulations allow interest owners to file pooling applications. Colgate is an interest owner as a result of the executed and filed conveyance, regardless of the BLM's administrative delay.

- 7. Fourth, the cases cited by Hartman have no bearing here. In *River Gas Corp. v. Pullman*, 960 F. Supp. 264 (D. Utah 1997), the court determined a quiet title action and held that the BLM's *denial* of a previous application for assignment did not control over a subsequent BLM-approved application for the same assignment. *Id. Geosearch, Inc. v. Andrus*, 508 F. Supp. 839, 847 (D. Wyo. 1981), is similarly inapposite, as in that case the court held that a party who has failed to apply for a transfer of interest with the BLM lacks standing to protest a lease. Unlike the circumstances addressed in those cases, Colgate has submitted the conveyance to BLM and no denial has occurred.
- 8. Moreover, in *Devon Energy Corp. v. U. S.*, 45 Fed. Cl. 519 (1999), the plaintiffs claimed an interest in a federal oil and gas lease but had not filed a transfer of operating rights and, therefore, no transfer had been approved by BLM. *Id.* at 531-2. Despite this fact, the court ruled that the plaintiffs had standing because "[t]he transfer approval and recording provisions of the [Mineral Leasing Act] serve BLM's internal administrative needs, and failure to abide by the provisions *does not impact the substantive property interests properly transferred to an assignee.*" *Id.* (emphasis added). The court reasoned that when the parties failed to file a transfer of operating rights, they agreed the transferor would remain obligated to the United States for all lease obligations and transferees would forfeit any rights to receive notice from BLM. Otherwise, the failure does not negate the proper transfer of property interests, which is governed by state law. *Id.* The conveyance of interest to Colgate is valid.
- 9. Despite Hartman's continued procedural machinations, Hartman has yet to provide any evidence that pooling his record title interest would violate his correlative rights or result in waste, which is the relevant inquiry for the Division in evaluating Colgate's applications. Colgate's applications should be granted.

10. Hartman's Motion to Dismiss has no merit and should be denied. This matter should proceed to hearing on January 19, 2023 in accordance with the Pre-Hearing Order.

This Conveyance, Assignment and Bill of Sale (this "Conveyance"), effective as of 12:01 a.m., Houston, Texas time, on September 1, 2021 ("Effective Time"), is made by and among OXY USA Inc., a Delaware corporation ("OUSA"), OXY USA WTP LIMITED PARTNERSHIP, a Delaware limited partnership ("WTP"), Occidental Permian Limited Partnership, a Texas limited partnership ("OPL"), and Oxy Y-1 Company, a New Mexico corporation ("OY1" and together with OUSA, WTP, and OPL, "Seller"), and Colgate Production, LLC, a Texas limited liability company ("Buyer").

This Conveyance is made pursuant and subject to the terms and conditions of that certain unrecorded Purchase and Sale Agreement between Seller and Buyer dated November 6, 2021 (the "Agreement"), the terms and conditions of which are hereby incorporated by reference. Capitalized terms used but not defined herein shall have the respective meanings assigned to such terms in the Agreement.
