Mewbourne Oil Company (“Mewbourne”) previously submitted for filing Exhibit 8. The undersigned believes some clarification is necessary:


Attached for convenience is Exhibit 5, submitted at the hearing. This is the publication “proof” sent to the undersigned pre-publication to approve (or revise) the published notice. Several items are highlighted, which are discussed below.

The affidavit of publication itself had not been received as of the hearing date. It has still not arrived. However, attached as Exhibit 8 is the billing statement from the Carlsbad newspaper, received on January 17, 2023, highlighting the 4th line.¹ A comparison of Exhibits 5 and Exhibit shows as follows:

1. The “Ad#” on Exhibit 5 and the “PO (publication order) Number” on Exhibit 8 are identical, No. 5526591.
2. The publication date is the same on each exhibit (December 20, 2022).
3. The amount billed is the same on each exhibit, \$143.48.

Based on the above, Mewbourne requests that Exhibits 5 and 8 combined be accepted as proof of publication notwithstanding the lack of receipt of an affidavit of publication.

Wayne Gill, or your heirs, devisees, successors, or assigns: Mewbourne Oil Company has filed an application with the New Mexico Oil Conservation Division (Case No. 23285) seeking an order pooling all uncommitted mineral interest owners in the Wolfcamp formation underlying a horizontal spacing unit comprised of the S/2 of Section 26 and the S/2 of Section 27, Township 22 South, Range 27 East, NMPM. The unit will be dedicated to (a) The Waterboy 26/27 WOIL Fee Well No. 1H, with a first take point in the NE/4SE/4 of 26 and a last take point in the NW/4SW/4 of Section 27, and (b) The Waterboy 26/27 WOPM Fee Well No. 1H, with a first take point in the SE/4SE/4 of 26 and a last take point in the SW/4SW/4 of Section 27. Also to be considered will be the cost of drilling, completing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, and equipping the wells. This matter is scheduled for hearing on January 5, 2023 at 8:15 a.m. During the current circumstances, state buildings are closed to the public and the hearing will be conducted remotely. You are not required to attend this hearing, but as an owner of an interest who may be affected by the application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from contesting this matter at a later date. A party appearing in a Division case is required by Division Rules to file a Pre-Hearing Statement no later than five business days before the hearing date. This statement may be filed online with the Division at ocd.hearings@emnrd.nm.gov, and should include: The name of the party and his or her attorney; a concise statement of the case; the name(s) of the witness(es) the party will call to testify at the hearing; the approximate time the party will need to present his or her case; and identification of any procedural matters that need to be resolved prior to the hearing.
