STATEMENT OF THE CASE

Earthstone applies for an order pooling all uncommitted interests in the First Bone Spring interval of the Bone Spring formation underlying a 319.95-acre, more or less, standard horizontal

spacing unit comprised of the W/2 E/2 of Section 34, Township 19 South, Range 33 East, and Lot 2, SW/4 NE/4, and W/2 SE/4 (W/2 E/2 equivalent) of irregular Section 3, Township 20 South, Range 33 East, Lea County, New Mexico (“Unit”). The spacing unit will be dedicated to the **Jade 34-3 Fed 1BS Com 11H** well (“Well”), to be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 34, Township 19 South, Range 33 East to a proposed bottom hole location in the SW/4 SE/4 (Unit O) of Section 3, Township 20 South, Range 33 East.

The completed interval of the Well will be orthodox. There is a depth severance in the Bone Spring formation within the Unit. Accordingly, Applicant seeks to pool interests from the top of the Bone Spring formation to a depth of approximately 9,570’ TVD.

Also to be considered will be the cost of drilling and completing the Well and the allocation of the costs, the designation of Applicant as the operator of the Unit and the Well, and a 200% charge for the risk involved in drilling and completing the Well.

The Well is located approximately 30 miles southwest of Hobbs, New Mexico.
