**ALPHA ENERGY PARTNERS, LLC'S
MOTION TO SUSPEND PRE-HEARING ORDER AND FOR STATUS CONFERENCE**

Alpha Energy Partners, LLC (“Alpha”) requests that the Division: (1) suspend the Amended Pre-Hearing Order, issued on November 17, 2022; and (2) set these cases for a status conference on February 16, 2023. In support of this motion, Alpha states the following.

1. The Amended Pre-Hearing Order, issued on November 17, 2022, set the above-referenced matters for a contested hearing on February 16, 2023 in conjunction with Mewbourne Oil Company (“Mewbourne”) Case Nos. 22093 and 22349 and Ascent Energy, LLC (“Ascent”) Case Nos. 22112 and 22184.

2. Since the issuance of the Amended Pre-Hearing Order, Mewbourne and Ascent have reached an agreement and dismissed their applications. *See* Joint Notice of Dismissal in Case Nos. 22093, 22349, 22112, and 22184, filed February 9, 2023.

3. Additionally, Realeza Del Spear, LP, which had opposed Alpha’s Application in Case No. 22172, filed a Notice of Withdrawal of Objection to Presentation by Affidavit on February 8, 2023.

4. Consequently, Alpha requests that the Division suspend the Amended Pre-Hearing Order and set these cases for a status conference on February 16, 2023.

5. None of the parties who have appeared in these matters object to this motion.
