STATEMENT OF THE CASE

In **Case No. 23325**, BTA applies for an order pooling all uncommitted interests in the Pennsylvanian Shale formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the E/2 E/2 of Section 13 and the E/2 NE/4 of Section 24, Township 17 South, Range 35 East, Lea County, New Mexico. The spacing unit will be dedicated to the **Hideout 22115 24-13 State Com #1H** well, to be drilled from a surface hole location in the SE/4 NE/4 (Unit H) of Section 24 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 13.

In **Case No. 23326**, BTA applies for an order pooling all uncommitted interests in the Pennsylvanian Shale formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Section 13 and the W/2 NE/4 of Section 24, Township 17 South, Range 35 East, Lea County, New Mexico. The spacing unit will be dedicated to the **Hideout 22115 24-13 State Com #2H** well, to be drilled from a surface hole location in the SW/4 NE/4 (Unit G) of Section 24 to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 13.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The Hideout 22115 24-13 State Com wells are located approximately 9 miles southwest of Lovington, New Mexico.
