STATEMENT OF THE CASE

In **Case No. 23333**, COG applies for an order: (1) establishing a 960-acre, more or less, non-standard horizontal spacing unit comprised of the S/2 of Section 12 and all of Section 13, Township 25 South, Range 34 East, Lea County, New Mexico; and (2) pooling all uncommitted interests from the base of the Avalon interval of the Bone Spring formation to the base of the Bone Spring formation underlying the spacing unit. The spacing unit will be dedicated to the following wells:

- **Bandana Fed Com 601H** well, to be horizontally drilled from a surface hole location in the SW/4 NE/4 (Unit G) of Section 12 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 13;
- **Bandana Fed Com 602H** well, to be horizontally drilled from a surface hole location in the SW/4 NE/4 (Unit G) of Section 12 to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 13;
- **Bandana Fed Com 603H** well, to be horizontally drilled from a surface hole location in the SE/4 NW/4 (Unit F) of Section 12 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 13; and
- **Bandana Fed Com 604H** well, to be horizontally drilled from a surface hole location in the SE/4 NW/4 (Unit F) of Section 12 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 13.

There is a depth severance in the Bone Spring formation within the spacing unit. Accordingly, Applicant seeks to pool interests from the base of the Avalon interval of the Bone Spring Formation at a stratigraphic equivalent of approximately 10,625' to the base of the Bone Spring Formation at a stratigraphic equivalent of approximately 12,671', as shown on the Jamaica 12 Federal 1 well log (API # 30-025-33451).

In **Case No. 23334**, COG applies for an order: (1) establishing a 960-acre, more or less, non-standard horizontal spacing unit comprised of the S/2 of Section 12 and all of Section 13, Township 25 South, Range 34 East, Lea County, New Mexico; and (2) pooling all uncommitted interests in the Wolfcamp formation underlying the spacing unit. The spacing unit will be dedicated to the following wells:

- **Bandana Fed Com 702H** well, to be horizontally drilled from a surface hole location in the SW/4 NE/4 (Unit G) of Section 12 to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 13;
- **Bandana Fed Com 703H** well, to be horizontally drilled from a surface hole location in the SE/4 NW/4 (Unit F) of Section 12 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 13;
- **Bandana Fed Com 704H** well, to be horizontally drilled from a surface hole location in the SE/4 NW/4 (Unit F) of Section 12 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 13.

The completed intervals of the Bandana Fed Com wells will be orthodox. Also to be considered in each case will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The Bandana Fed Com wells are located approximately 13 miles west of Jal, New Mexico.
