APPLICANT'S STATEMENT OF CASE

Goodnight Midstream Permian, LLC requests that the Division enter an order pursuant to 19.15.4 NMAC and 19.15.7.16.A NMAC withholding Empire New Mexico, LLC's ("Empire")

allowable for its EMSU #462 well until Empire confirms the well's status and construction by filing a Form C-105 well recompletion report and the required well tests with the Division.

Empire (OGRID 330679) is the designated operator of the EMSU #462 well (API No. 30-25-29622). Division rules require that a C-105 and confirmatory tests be filed after completion or recompletion of a well; otherwise, the Division is required to withhold the allowable for the well authorized by an approved C-104. *See* 19.15.7.16.A NMAC. The Division's well file for the EMSU #462 reflects that the well was proposed to be recompleted from a San Andres water supply well to a Grayburg oil production well. The production records reflect that the recompletion was performed; however, the EMSU #462 well file does not contain a C-105 well re-recompletion report confirming that the work was done, and Empire has confirmed that it does not have any such documentation in its possession. No Form C-105 or any other subsequent report filings are available in the well file confirming that the recompletion was done as planned, and Empire has confirmed that it has no records on the status or construction of the well and has been unable to provide confirmation that a C-105 or any subsequent report was ever filed. Until Empire complies with the Division's rules and files the required C-105 and confirmatory test reports for the EMSU #462, the Division is required to suspend Empire's allowable for the EMSU #462.

Under the Division's rules, Empire, as current operator of the EMSU #462 well, must confirm the well's status and construction through wireline logs, a temperature survey, or other confirmatory well tests, and to file with the Division a C-105 report with the confirmatory logs and summaries. *See* 19.15.7.16 NMAC. If Empire refuses to do so, the Division must withhold Empire's allowable for the EMSU #462 and suspend its authority to transport oil under its C-104 authorization until Empire confirms the well's construction and status by filing a C-105 report with the required confirmatory logs and summaries required by the Division's regulations. *See Bd*.

of Educ. v. Jennings, 1982-NMCA-135, ¶ 94, 651 P.2d 1037 ("An administrative agency must follow its own regulations." (emphasis added)).
