STATEMENT OF THE CASE

In **Case No. 23349**, COG applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 E/2 of Sections 5 and 8, Township 26 South, Range 29 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Hambone Federal Com #501H** well, drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 8 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 5.

In **Case No. 23350**, COG applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Sections 5 and 8, Township 26 South, Range 29 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Hambone Federal Com #502H** well, drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 8 to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 5.

In **Case No. 23351**, COG applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 280-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Section 5 and the E/2 NW/4 and NE/4 SW/4 of Section 8, Township 26 South, Range 29 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Hambone Federal Com #505H** well, drilled from a surface hole location in the NE/4 SW/4 (Unit K) of Section 8 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 5.

In **Case No. 23352**, COG applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 280-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Section 5 and the W/2 NW/4 and NW/4 SW/4 of Section 8, Township 26 South, Range 29 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Hambone Federal Com #506H** well, drilled from a surface hole location in the NE/4 SW/4 (Unit K) of Section 8 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 5.

The completed intervals of the Hambone Federal Com wells will be orthodox. Also to be considered in each case will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The Hambone Federal Com wells are located approximately 10.4 miles south of Malaga, New Mexico.
