Earthstone applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 319.95-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Section 34, Township 19 South, Range 33 East, and Lot 2, SW/4 NE/4, and W/2 SE/4 (W/2 E/2 equivalent) of irregular Section 3, Township 20 South, Range 33 East, Lea County, New Mexico ("Unit"). The spacing unit will be dedicated to the **Jade 34-3 Fed 1BS Com 11H** well ("Well"), to be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 34,

Township 19 South, Range 33 East to a proposed bottom hole location in the SW/4 SE/4 (Unit O) of Section 3, Township 20 South, Range 33 East.
