APPLICANT’S STATEMENT OF THE CASE

In Case No. 23370, Earthstone seeks an order (1) establishing a standard 323.35 acre, more or less, spacing and proration unit comprised of the W/2 E/2 of Section 34, Township 18 South, Range 33 East, NMPM, and Lot 2 (NW/4 NE/4 equivalent), SW/4 NE/4, and the W/2 SE/4 of

Section 3, Township 19 South, Range 33 East, NMPM, all in Lea County, New Mexico, and (2) pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying said unit. Earthstone proposes and dedicates to the HSU, the **Skylark 34-3 Fed Com 1BS 3H Well** and the **Skylark 34-3 Fed Com 2BS 7H Well**, as initial wells, to be drilled to a sufficient depth to test the Bone Spring formation. The proposed wells will be orthodox in location.

Earthstone proposes the **Skylark 34-3 Fed Com 1BS 3H Well**, an oil well, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of Section 27-T18S-R33E, NMPM, Lea County, to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 3-T19S-R33E, NMPM, Lea County.

Earthstone proposes the **Skylark 34-3 Fed Com 2BS 7H Well**, an oil well, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of Section 27-T18S-R33E, NMPM, Lea County, to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 3-T19S-R33E, NMPM, Lea County.
