**APPLICANT’S STATEMENT OF THE CASE**

In Case No. 23374, Earthstone seeks an order (1) establishing a standard 320-acre, more or less, spacing and proration unit comprised of the S/2 N/2 of Sections 9 and 10, Township 19 South, Range 33 East, NMPM, Lea County, New Mexico, and (2) pooling all uncommitted mineral

interests in the Bone Spring formation, designated as an oil pool, underlying said unit. Earthstone proposes and dedicates to the HSU the **DeLorean 9-10 Fed 1BS Com 2H Well**, and the **DeLorean 9-10 Fed 2BS Com 6H Well**, as initial wells, to be drilled to a sufficient depth to test the Bone Spring formation. The proposed wells will be orthodox in location.

Earthstone proposes the **DeLorean 9-10 Fed 1BS Com 2H Well**, an oil well, to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 9 to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 10.

Earthstone proposes the **DeLorean 9-10 Fed 2BS Com 6H Well**, an oil well, to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 9 to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 10.
