The unit will be dedicated to the North Wilson Deep Unit Well No. 8H, with a first take point in the SW/4SE/4 of Section 18 and a last take point in the NW/4NE/4 of Section 7. Also to be considered will be the cost of drilling, completing, testing, and equipping the well and the allocation of the cost thereof,

as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling, completing, testing, and equipping the well.


