## BTA OIL PRODUCERS, LLC'S UNOPPOSED MOTION FOR CONSOLIDATION AND TO SUSPEND PRE-HEARING ORDER

BTA Oil Producers, LLC ("BTA") requests that the Oil Conservation Division ("Division"): (1) consolidate Case Nos. 23361 and 23507 with Case Nos. 23479 and 23480 for hearing; (2) suspend the Pre-Hearing Order issued on March 3, 2023; and (3) set the cases for a status conference on May 4, 2022. In support of this motion, BTA states the following.

- 1. BTA's Case Nos. 23479 and 23480 involve competing proposals with Texas Standard Operating NM LLC's ("Texas Standard") Case Nos. 23361 and 23507.
- 2. BTA's applications were filed on April 3, 2023 and are set for hearing on May 4, 2023.
- 3. Texas Standard's Case No. 23361 is currently set for a contested hearing on May 4, 2023 under the Pre-Hearing Order issued on March 3, 2023.
- 4. Texas Standard's Case No. 23507 was filed on April 13, 2023 and is currently set for hearing on June 1, 2023.
- 5. BTA and Texas Standard agree that Case Nos. 23361, 23507, 23479 and 23480 should be consolidated for hearing.

- 6. As a result, BTA requests that the Division suspend the pre-hearing order and set the competing applications for a status conference on May 4, 2023 to select a contested hearing date.
  - 7. No party opposes this request.

For the foregoing reasons, BTA requests that the Division: (1) consolidate Case Nos. 23361 and 23507 with Case Nos. 23479 and 23480 for hearing; (2) suspend the Pre-Hearing Order; and (3) set the cases for a status conference on May 4, 2022.
