STATEMENT OF THE CASE

APPLICANT

Mewbourne seeks an order re-opening Case No. 22841 and pooling all uncommitted mineral interest owners in the Bone Spring formation in a horizontal spacing unit comprised of the N/2N/2 of Section 25 and the N/2NE/4 of Section 26, Township 18 South, Range 31 East, NMPM. The unit will be dedicated to the Deep Ellum 25/26 Fed. Com. Well No. 511H (f/k/a the Deep Ellum 25/26 B2AB Fed. Com. Well No. 1H) and the tthe Deep Ellum 25/26 Fed. Com. Well No. 611H, horizontal wells with first take points in the NE/4NE/4 of Section 25 and last take points in the NW/4NE/4 of Section 26. Also to be considered will be the cost of drilling, completing, testing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, testing, and equipping the wells.
