In Case No. 23593, Devon seeks to reopen Case No. 23148 and amend Order No. R-22530 in order to pool certain additional record title owners in the Wolfcamp formation, designated as an oil pool, underlying a nonstandard 600-acre, more or less, spacing and proration unit comprised of

the W/2 of Section 26 and the NW/4 and the N/2 SW/4 and the SE/4 SW/4 of Section 35 (also described as the W/2 of Sections 26 and 35 less the SW/4 SW/4 of Section 35), Township 22 South, Range 33 East, NMPM, Lea County, New Mexico. Devon proposed and dedicated to the unit, the **Serpentine 35-26 Fed Com 2H Well** and the **Serpentine 35-26 Fed Com 10H Well** as initial wells. The proposed wells will be orthodox in location.

Devon proposed the **Serpentine 35-26 Fed Com 2H Well** to be horizontally drilled from a surface location in the NW/4 SW/4 (Unit L) of Section 35 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 26.

Devon proposed the **Serpentine 35-26 Fed Com 10H Well** to be horizontally drilled from a surface location in the SE/4 SW/4 (Unit N) of Section 35 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 26.
