In Case No. 23618, Manzano seeks an order: (1) pooling all uncommitted interests in the Avalon, Bone Spring formation underlying a standard 320-acre, more or less, horizontal well spacing unit comprised of the SE/4N/4 of Section 6, the S/2S/2 of Section 5 and S/2NW/4 of Section 4, Township 20 South, Range 26 East, NMPM, Eddy County, New Mexico; and (2) dedicating the standard horizontal spacing unit to the proposed initial Mia 64 Fee #2H well, to be

drilled horizontally from a surface hole location in the SE/4NE/4 of Section 6 to a bottom hole location in the SW/4NE/4 of Section 4.
