In Case No. 23581, Permian seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Sections 21 and 22, Township 18 South, Range 31 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Pinkie Pie 22-21 Fed Com 121H** and **Pinkie**

Pie 22-21 Federal Com 131H wells, which will be drilled from surface hole locations in the NE/4 NE/4 (Unit A) of Section 22, to bottom hole locations in the NW/4 NW/4 (Unit D) of Section 21.

In **Case No. 23582**, Permian seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 21 and 22, Township 18 South, Range 31 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Pinkie Pie 22-21 Fed Com 122H** and **Pinkie Pie 22-21 Federal Com 132H** wells, which will be drilled from surface hole locations in the SE/4 NE/4 (Unit H) of Section 22, to bottom hole locations in the SW/4 NW/4 (Unit E) of Section 21.

In **Case No. 23583**, Permian seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Sections 21 and 22, Township 18 South, Range 31 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Pinkie Pie 22-21 Fed Com 123H** and **Pinkie Pie 22-21 Federal Com 133H** wells, which will be drilled from surface hole locations in the NE/4 SE/4 (Unit I) of Section 22, to bottom hole locations in the NW/4 SW/4 (Unit L) of Section 21.

In **Case No. 23648**, Permian seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Sections 21 and 22, Township 18 South, Range 31 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Pinkie Pie 22-21 Fed Com 124H** and **Pinkie Pie 22-21 Federal Com 134H** wells, which will be drilled from surface hole locations in the SE/4 SE/4 (Unit P) of Section 22, to bottom hole locations in the SW/4 SW/4 (Unit M) of Section 21.

The completed intervals of the Pinkie Pie 22-21 Fed Com wells will be orthodox. The wells are located approximately 32.64 miles southeast of Artesia, New Mexico.
