STATEMENT OF THE CASE

In **Case No. 23664**, BTA applies for an order pooling all uncommitted interests in the Pennsylvanian Shale formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 27 and 22, Township 16 South, Range 36 East, Lea County, New Mexico. The spacing unit will be dedicated to the **Capitan 22301 27-22 State Com #19H** well, to be drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 27 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 22.

In **Case No. 23665**, BTA applies for an order pooling all uncommitted interests in the Pennsylvanian Shale formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 27 and 22, Township 16 South, Range 36 East, Lea County, New Mexico. The spacing unit will be dedicated to the **Capitan 22301 27-22 State Com #20H** well, to be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 27 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 22.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The Capitan 22301 27-22 State Com #19H and #20H wells are located approximately 3 miles south of Lovington, New Mexico.
