#### STATEMENT OF THE CASE

Ridge Runner seeks to pool additional uncommitted interests under the terms of Order No. R-21609 ("Order"). The Order pooled all uncommitted mineral interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2W/2 of Sections 2 and 11, Township 20 South, Range 35 East in Lea County ("Unit") and dedicated the unit to the Zeus 2-11 Fed Com #1H well ("Well"). The order designated Applicant as the operator of the unit and the well. On April 13, 2023, the Division entered Order No. R-

21609-C in Case No. 23280 granting an extension to drill the Well within the Unit until February 23, 2024. Since the Order was entered, Ridge Runner has identified an additional interest in the Unit that has not been pooled under the terms of the Order. Ridge Runner requests that the additional uncommitted interest be pooled under the terms of Order No. R-21609.

The well is located approximately 16 miles southwest of Hobbs, New Mexico.
