**UNOPPOSED MOTION TO AMEND THE  
FURTHER AMENDED PRE-HEARING ORDER  
AND FOR A CONTINUANCE**

Cimarex Energy Co. (“Cimarex”), through its undersigned attorneys, moves the New Mexico Oil Conservation Division (“Division”) to: (1) amend the Further Amended Pre-Hearing Order (“PHO”) in these cases that was issued on May 12, 2023 and (2) continue these cases to the September 21<sup>st</sup> docket or, if unavailable, to the next available docket. In support of this motion, the following is shown:

1. The competing applications are set for hearing on the August 17<sup>th</sup> docket pursuant to the Further Amended PHO.

2 Cimarex and Tap Rock believe that it is possible that they may be able to resolve their differences within the next several weeks which would negate the need for a contested hearing.

3. To that end, Cimarex requests these matters be continued to the September 21<sup>st</sup> docket or, if unavailable, to the next available docket.

4. Counsel for Tap Rock has agreed to this request and counsel for EOG Resources, Inc., which entered an appearance in Case Nos. 23232 and 23234, indicated that her client will not interpose an objection to this motion.
