In **Case No. 23734**, Read & Stevens applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Section 3, Township 20 South, Range 34 East, Lea County, New Mexico. Applicant seeks to dedicate the Unit to the **North Lea 3 Fed Com 2H** well, drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 3, to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 3.

In **Case No. 23735**, Read & Stevens applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Section 3, Township 20 South, Range 34 East, Lea County, New Mexico. Applicant seeks to dedicate the Unit to the **North Lea 3 Fed Com 3H** well, which is drilled from a surface hole location in the NE/4 NW/4 (Unit C) of Section 3 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 3.

In **Case No. 23736**, Read & Stevens applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Section 3, Township 20 South, Range 34 East, Lea County, New Mexico. The Unit will be dedicated to the **North Lea 3 Fed Com 4H** well, which is drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 3, to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 3.

The completed intervals of the wells will be orthodox. The Wells are located approximately 24.92 miles Southwest of Hobbs, New Mexico.
