**STATEMENT OF THE CASE**

In **Case No. 23759**, Permian Resources applies for an order pooling all uncommitted interests from the top of the Third Bone Spring formation to the base of the Bone Spring Formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Sections 35 and 36, Township 19 South, Range 29 East, Eddy County, New Mexico. The Unit will be dedicated to the **Silver Bar 35 Fed State Com 133H** well, which will be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 34 to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 36.

In **Case No. 23760**, Permian Resources applies for an order pooling all uncommitted interests from the top of the Third Bone Spring formation to the base of the Bone Spring Formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Sections 35 and 36, Township 19 South, Range 29 East, Eddy County, New Mexico. The Unit will be dedicated to the **Silver Bar 35 Fed State Com 134H** well, which will be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 34 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 36.

There is a depth severance in the Bone Spring Formation within the Unit. As a result, in both cases, Permian Resources seeks to pool interests in the Third Bone Spring Formation from the stratigraphic equivalent of approximately 8,205' TVD to the base of the Bone Spring Formation as shown on the Osage Federal 10 well log (API #30-015-26178).

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The Wells are located approximately 13 miles northwest of Carlsbad, New Mexico.
