STATEMENT OF THE CASE

In Case No. 23668, Colgate applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the N/2 NE/4 of Section 29 and the N/2 N/2 of Section 28, Township 18 South, Range 31 East, Eddy County, New Mexico. The spacing unit will be dedicated to the Silver 29-28 Fed Com 121H and Silver 29-28 Fed Com 131H wells, which will be drilled from surface hole locations in the SW/4 NE/4 (Unit G) of Section 29 to bottom hole locations in the NE/4 NE/4 (Unit A) of Section 28.

In Case No. 23669, Colgate applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the S/2 NE/4 of Section 29 and the S/2 N/2 of Section 28, Township 18 South, Range 31 East, Eddy County, New Mexico. The spacing unit will be dedicated to the Silver 29-28 Fed Com 122H and Silver 29-28 Fed Com 132H wells ("Wells"), which will be drilled from surface hole locations in the SW/4 NE/4 (Unit G) of Section 29 to bottom hole locations in the SE/4 NE/4 (Unit H) of Section 28.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells. The Wells are located approximately 30.57 miles southeast of Artesia, New Mexico.
