APPLICANT

The unit will be dedicated to the Judge 3/4 B3HE Fed. Com. Well No. 1H, with a first take point in the SE/4NE/4 of Section 3 and a last take point in the SW/4NW/4 of Section 4.

Case No. 23690: Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the N/2S/2 of Section 3 and the N/2S/2 of Section 4, Township 20 South, Range 29 East, NMPM. The unit will be dedicated to the Judge 3/4 B3IL Fed. Com. Well No. 1H, with a first take point in the NE/4SE/4 of Section 3 and a last take point in the NW/4SW/4 of Section 4.

Case No. 23691: Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2S/2 of Section 3 and the S/2S/2 of Section 4, Township 20 South, Range 29 East, NMPM. The unit will be dedicated to the Judge 3/4 B3PM Fed. Com. Well No. 1H, with a first take point in the SE/4SE/4 of Section 3 and a last take point in the SW/4SW/4 of Section 4.

Also to be considered will be the cost of drilling, completing, testing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, testing, and equipping the wells.




