The unit will be dedicated to the Iron Islands 11/7 B2OP Fed. Com. Well No. 1H, with a first take point in the SW/4SE/4 of Section 11 and a last take point in the SE/4SE/4 of Section 7.

Also to be considered will be the cost of drilling, completing, testing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a cost plus 200% charge for the risk involved in drilling, completing, testing, and equipping the wells.
