**UNOPPOSED MOTION TO AMEND PRE-HEARING ORDER**

(“V-F”), through its undersigned attorneys, moves the New Mexico Oil Conservation Division (“Division”) to amend the Pre-hearing Order (“PHO”) that was issued on October 6, 2023, for Case Nos. 23825 through 23827, respectfully requesting that Case Nos. 23874 and 23875 be added to the PHO in order that they can be heard as competing applications at the scheduled January 4, 2023, hearing. In support of this request, V-F states the following:

On October 2, 2023, V-F filed applications for compulsory pooling in Cases Nos. 23874 and 23875, covering the S/2 N/2 and S/2 of Sections 4 and 5, Township 19 South, Range 28 East, NMPM, Eddy County, New Mexico, which overlap with the applications filed by Permian Resources Operating, LLC, and the Division at the status conference on October 5, 2023, considered it appropriate to include V-F’s applications as competing applications in the above-referenced cases. V-F provides this Motion for the Division’s consideration. Counsel has been informed and does not object.
