APPLICATION

V-F Petroleum Inc. ("V-F Petroleum" or "Applicant"), OGRID No. 24010, through its undersigned attorneys, hereby files this Application with the Oil Conservation Division ("Division") pursuant to the provisions of NMSA 1978, Section 70-2-17, seeking an order pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a standard 324.84-acre, more or less, spacing and proration unit comprised of Lots 1 through 4 (N/2 N/2 equivalent) of Sections 4 and 5, Township 19 South, Range 28 East, NMPM, Eddy County, New Mexico. Sections 4 and 5 are irregular Sections which contain correction lots.

In support of its Application, V-F Petroleum states the following:

1. V-F Petroleum is a working interest owner in the proposed horizontal spacing and proration unit ("HSU") and has a right to drill a well thereon.

2. V-F Petroleum proposes and dedicates to the HSU the **Courtman 4 State Com** #222H Well and the **Courtman 4 State Com** #232H Well as initial wells to be drilled to a sufficient depth to test the Bone Spring formation.

3. V-F Petroleum proposes the **Courtman 4 State Com #222H Well**, an oil well, to be horizontally drilled from a surface location in Lot 1 (NE/4 NE/4 equivalent) of Section 4 to a bottom hole location in Lot 4 (NW/4 NW/4 equivalent) of Section 5.

4. V-F Petroleum proposes the **Courtman 4 State Com #232H Well**, an oil well, to be horizontally drilled from a surface location in Lot 1 (NE/4 NE/4 equivalent) of Section 4 to a bottom hole location in Lot 4 (NW/4 NW/4 equivalent) of Section 5.

5. The proposed wells are orthodox in their locations, and the take points and completed intervals comply with setback requirements under the statewide rules.

6. V-F Petroleum has sought in good faith but has been unable to obtain a voluntary agreement from all interest owners to participate in the drilling of the wells or the commitment of their interests to the wells for their development within the proposed HSU.

7. The pooling of all interests in the Bone Spring formation within the proposed HSU will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

8. In order to provide for its just and fair share of the oil and gas underlying the subject lands, V-F Petroleum requests that all uncommitted interests in this HSU be pooled and that V-F Petroleum be designated the operator of the proposed horizontal wells and HSU.

WHEREFORE, V-F Petroleum requests that this Application be set for hearing on September 7, 2023, before an Examiner of the Oil Conservation Division, and after notice and hearing as required by law, the Division enter an order:

A. Establishing a standard 324.84-acre, more or less, spacing and proration unit comprised of Lots 1 through 4 (N/2 N/2 equivalent) of Sections 4 and 5, Township 19 South, Range 28 East, NMPM, Eddy County, New Mexico;

B. Pooling all uncommitted mineral interests in the Bone Spring formation underlying the proposed HSU.

C. Approving the Courtman 4 State Com #222H Well and the Courtman 4 StateCom #232 Well as the wells for the HSU.

D. Designating V-F Petroleum as operator of this HSU and the horizontal wells to be drilled thereon;

E. Authorizing V-F Petroleum to recover its costs of drilling, equipping, and completing the wells;

F. Approving actual operating charges and costs of supervision, to the maximum extent allowable, while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and

G. Setting a 200% charge for the risk assumed by V-F Petroleum in drilling and completing the wells in the event a working interest owner elects not to participate in the wells.

V-F Petroleum proposes the **Courtman 4 State Com #222H Well,** an oil well, to be horizontally drilled from a surface location in Lot 1 (NE/4 NE/4 equivalent) of Section 4 to a bottom hole location in Lot 4 (NW/4 NW/4 equivalent) of Section 5.

PROCEDURAL MATTERS

Permian Resources Operating, LLC ("Permian Resources") made an entry of appearance in this case and objected to the case going forward by affidavit. Consequently, the Division set a hearing date for October 19, 2023, pursuant to the Pre-hearing Order dated September 7, 2023. Witnesses will be available at the time of the hearing to address questions.

MATERIAL FACTS NOT IN DISPUTE

1. V-F Petroleum is a majority Working Interest ("WI") owner in the proposed unit with individual ownership of 57.7% interest in the unit. *See* Unit Recapitulation in V-F Petroleum's Exhibit A-2, included in the Hearing Packet. With owners supporting V-F Petroleum through JOA Joinder, V-F Petroleum controls approximately 64.6% interest in the proposed unit. *See id.*

2. V-F Petroleum has experience as an operator drilling horizontal wells comparable to the Courtman 4 State Com #222H and #232H Wells in this general area of development.

3. V-F Petroleum's witnesses have been recognized as expert witnesses by the Division, and their credentials have been accepted as a matter of record.

4. The laydown orientation is the preferred orientation of the proposed unit given the nature of the geology.

LIST OF DISPUTED FACTS AND ISSUES

Relevant disputed facts and issues were addressed and ruled on by the Division at the Status Conference held on October 5, 2023, which allowed V-F Petroleum to go forward with the hearing of its application for compulsory pooling on October 19, 2023. V-F Petroleum is not aware of

SELF-AFFIRMED STATEMENT OF SEAN JOHNSON

I, being duly sworn on oath, state the following:

1. I am over the age of eighteen years and have the capacity to execute this Statement, which is based on my personal knowledge.

2. I am employed as a Landman with V-F Petroleum Inc., ("V-F Petroleum"), and I am familiar with the subject application and the lands involved.

3. I graduated in 2009 from Texas Tech University with a bachelor's degree in Energy Commerce. I have worked at V-F Petroleum for approximately 1 year, and I have been working in New Mexico for (12) Twelve years. I have previously testified before the New Mexico Oil Conservation Division ("Division"), and my credentials as a petroleum landman have been accepted by the Division as a matter of record.

4. This Statement is submitted in connection with the filing by V-F Petroleum of the above-referenced compulsory pooling applications pursuant to 19.15.4.12.A(1).

5. V-F Petroleum seeks an order pooling all uncommitted mineral interest in the Bone Spring formation (Travis; Bone Springs; Pool Code: [97257]) underlying a standard 324.84-acre, more or less, spacing and proration unit comprised of Lots 1 through 4 (N/2 N/2 equivalent) of Sections 4 and 5, Township 19 South, Range 28 East, NMPM, Eddy County, New Mexico.



6. Under Case <u>No. 23728</u>, V-F Petroleum seeks to dedicate to the HSU two initial oil wells: the **Courtman 4 State Com #222H Well** and the **Courtman 4 State Com #232H Well**.

7. The **Courtman 4 State Com #222H Well,** an oil well, API No. pending, is to be horizontally drilled from a surface location in Lot 1 (NE/4 NE/4 equivalent) (1,310' FNL, 250' FEL) of Section 4 to a bottom hole location in Lot 4 (NW/4 NW/4 equivalent) (810' FNL, 100' FWL) of Section 5; approximate TVD of 7,255'; approximate TMD of 17,225'; FTP in Section 4: 810' FNL, 100' FEL; LTP in Section 5: 810' FNL, 100' FWL.

8. The **Courtman 4 State Com #232H Well,** an oil well, API No. pending, is to be horizontally drilled from a surface location in Lot 1 (NE/4 NE/4 equivalent) (1,285' FNL, 250' FEL) of Section 4 to a bottom hole location in Lot 4 (NW/4 NW/4 equivalent) (750' FNL, 100' FWL) of Section 5; approximate TVD of 8,355'; approximate TMD of 18,325'; FTP in Section 4: 750' FNL, 100' FEL; LTP in Section 5: 750' FNL, 100' FWL.

9. The proposed C-102 for each well is attached as **Exhibit A-1**.

10. A general location plat and a plat outlining the unit being pooled is attached hereto as **Exhibit A-2**, which show the location of the proposed wells within the unit. The well locations are orthodox, and they meet the Division's setback requirements.

The parties being pooled and the nature of their interests, are listed on Exhibit A-2 attached hereto. Exhibit A-2 includes information regarding the working interest owners, and the record title owners to be pooled.

12. There are no depth severances in the Bone Spring formation in this acreage.

13. A good faith review of records did not reveal any overlapping units.

14. I provided the law firm of Abadie & Schill P.C. a list of names and addresses for the uncommitted interest owners shown on **Exhibit A-2**. In compiling these addresses, I

conducted a diligent search of the public records in Eddy County, New Mexico, where the wells are located, and of phone directories and did computer searches to locate the contact information for parties entitled to notification. All the owners were locatable. Three letters to Working Interest owners are still listed as In Transit: White, Theodore P. whose wife is Marianne White; Pamela Ann Evans; and Anne S. Johnson; however, V-F Petroleum has been in contact with these owners, as shown in Exhibit A-4. V-F Petroleum published notice in the Carlsbad Current-Argus, a newspaper of general circulation in Eddy County, New Mexico, to account for any unlocatable parties and cover any contingencies regarding notice.

15. V-F Petroleum has made a good faith effort to negotiate with the interest owners, but has been unable to obtain, voluntary agreement from all interest owners to participate in the drilling of the wells or in the commitment of their interests to the wells for their development within the proposed horizontal spacing unit. **Exhibit A-4** provides a chronology and history of contacts with the owners.

16. V-F Petroleum has made good faith effort to contact the interest owners being pooled, but said owners have failed or refused to voluntarily commit their interest in the wells. However, V-F Petroleum has been in ongoing discussions with some of the interest owners to voluntarily enter into a Joint Operating Agreement. If a mutually agreeable Joint Operating Agreement is reached between V-F Petroleum and another interest owner or owners, V-F Petroleum requests that the voluntary agreement become operative and supersede the Division's order for said parties, except to the extent the Division deems it necessary to maintain spacing criteria for the purpose of conservation, the prevention of waste, and protection of correlative rights.

17. **Exhibit A-3** is a sample proposal letter and the AFEs for the proposed wells. The estimated cost of the wells set forth in the AFEs is fair, reasonable, and comparable to the costs of other wells of similar depths and lengths drilled in this area of New Mexico.

18. V-F Petroleum requests overhead and administrative rates of \$8,500/month for drilling each well and \$850/month for producing each well. These rates are fair and comparable to the rates charged by other operators for wells of this type in this area of southeastern New Mexico. V-F Petroleum requests that these rates be adjusted periodically as provided in the COPAS Accounting Procedure.






1. I am a geologist with V-F Petroleum, Inc. ("V-F"). I am over 18 years of age, have personal knowledge of the matters addressed herein, and am competent to provide this Self-Affirmed Statement. I have previously testified before the New Mexico Oil Conservation Division ("Division"), and my credentials as an expert in petroleum geology matters were accepted and made a matter of record.

2. I am familiar with the geological matters that pertain to the above-referenced case.

3. This affidavit is submitted in connection with the filing by V-F of the above referenced compulsory pooling.

4. Exhibit B-1 is a location map of the proposed horizontal spacing unit ("Unit") that is outlined by a dark blue rectangle. The planned wellbore path for the proposed Courtman 4 State Com #222H is represented by a green dashed line, and the planned wellbore path for the proposed Courtman 4 State Com #232H well is represented by a red dashed line. Existing producing wells in the targeted intervals are represented by green and red solid lines. Green wells are horizontals that produce from the 2nd Bone Spring formation, and red wells are horizontals that produce from the 3rd Bone Spring formation.

5. **Exhibit B-2** is a subsea structure map with a contour interval of 100 feet that is representative of the 2nd Bone Spring Sand target interval. The data points are indicated by red crosses along with their corresponding subsea values posted above in blue. The planned wellbore



path for the 2nd Bone Spring Sand well is depicted by a green dashed line. The map demonstrates the formation is dipping to the southeast in this area. I do not observe any faulting, pinch-outs, or geologic impediments to developing the targeted interval with horizontal wells. Also identified on this exhibit are five wells that were used to construct a structural cross-section from A to A'. I used these particular well logs because they penetrate the targeted intervals, are of good quality, and are representative of the geology in the area.

6. **Exhibit B-3** is a subsea structure map with a contour interval of 100 feet that is representative of the 3rd Bone Spring Sand target interval. The data points are indicated by red crosses along with their corresponding subsea values posted above in blue. The planned wellbore path for the 3rd Bone Spring Sand well is depicted by a red dashed line. The map demonstrates the formation is dipping to the southeast in this area. I do not observe any faulting, pinch-outs, or geologic impediments to developing the targeted interval with horizontal wells. As with **Exhibit B-2**, the same path of the five well structural cross section A to A' is included.

7. **Exhibit B-4** is a structural cross-section using the representative Wells identified on **Exhibits B-2 and B-3**. It contains gamma ray, resistivity and porosity logs. The proposed landing zones for the Wells is labeled on the exhibit. This cross-section demonstrates the target interval is continuous across the Unit.

8. **Exhibit B-5** is a gun barrel representation of the Unit depicting vertical and horizontal distances between each planned well.

9. In my opinion, a laydown orientation for the Wells is appropriate to properly develop the subject acreage because of consistent rock properties throughout the Unit and the preference to be perpendicular to the inferred maximum horizontal stress of the area. Laydown

orientation is also supported by a study of the production of stand-up vs laydown orientation in the area, with production results greatly favoring a laydown orientation.

10. Based on my geologic study of the area, the targeted intervals underlying the Unit is suitable for development by horizontal wells and the tracts comprising the Unit will contribute more or less equally to the production of the wells.

11. In my opinion, the granting of V-F's application will serve the interests of conservation, the protection of correlative rights, and the prevention of waste.


