**STATEMENT OF THE CASE**

In **Case No. 23882**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 1 and 2, Township 20 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the King Eider 12 Fed Com 502H well,

to be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 12 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 1.

In **Case No. 23883**, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Sections 1 and 2, Township 20 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the following wells: King Eider 12 Fed Com 503H, to be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 12 to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 1; and King Eider 12 Fed Com 504H, to be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 12 to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 1.

In **Case No. 23884**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 E/2 of Sections 1 and 2, Township 20 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the King Eider 12 Fed Com 505H well, to be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 12 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 1.

The completed interval of the King Eider 12 Fed Com 503H and 504H wells will be unorthodox. The completed interval of the King Eider 12 Fed Com 505H and 502H wells will be orthodox. Also to be considered in each case will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The wells are located approximately 18 miles southwest of Hobbs, New Mexico.
